

# **TECHNICAL DATA**E Series - Epoxies

The E series Epoxy powder coatings are designed primarily as primers for use in exterior applications. They have outstanding adhesion and functionality when combined with a UV stable topcoat. The resulting 2-coat system offers outstanding protection.

When used as a primer, the coated part should be partially baked in the oven long enough to allow the epoxy to "gel" and flow into a continuous film. The part is then ready for the topcoat application followed by a secondary full cure for both coatings (typically 10 minutes @ 200C).
